BUSINESS VISAS VIA JNZBC:

While entry restrictions into Japan remain fluid and may ease over time (noting Japan has recently lifted the requirement for PCR testing), the requirement for the Japan Chamber of Commerce and Industry (our counterpart organisation) to “sponsor” our NZ delegates attending the conference, as well as the need for delegates to apply for a Business Visa **remains an essential requirement for everyone to enter Japan**. In practice, this amounts to the JCCI signing a pledge guaranteeing that NZ delegates will comply with Japanese Covid health and safety regulations during their stay in Japan. In return, we have signed a MoU with the JCCI undertaking to ensure that NZ delegates are fully informed of the pledge and accept the need to comply with Japanese rules and requirements.
