## **TERMS AND CONDITIONS**

## **Conditions of Application**

- 1) The information requested in the application form will be used for assessment purposes. All personal information collected during the application process may be made available to members of the selection committee to choose the successful applicants (Selected Applicants).
- 2) North Asia CAPE will normally hold documents about Selected Applicants for the duration of the award.
- 3) North Asia CAPE retains the right take images, video, and audio of participants to let our North Asia CAPE community know about the impacts and outcomes of your tour via social media platforms.
- 4) Consistent with the provisions of the Privacy Act, applicants have the right of access to information held about them. Applicants also have the right to request the correction of information held about them.
- 5) North Asia CAPE wishes to recognise Selected Applicants and to keep informed about the progress of the applicants it has supported. In accepting this opportunity, you authorise North Asia CAPE to release information about your experience.
- 6) Participation in the Study Tour to China is voluntary and North Asia CAPE and its Programme Partners shall not be held liable for any damages, losses, or related claims as a result of an unforeseeable or unavoidable acts and risks.

## Regulations

- 1) North Asia CAPE will award places based on the recommendations of the Selection Committee.
- 2) The award is tenable only by participants who are citizens or permanent residents of New Zealand. Preference will be given to 'emerging business leaders'.
- 3) The application closing date is on 19 Feb, 2024 unless otherwise stated.

- 4) Selected Applicants will be known as North Asia Centre of Asia-Pacific Excellence Scholars (CAPE Scholars).
- 5) Selected Applicants will be provided with the following at no cost for their full participation in the programme:
- a. International Travel to China
- b. Domestic transfers to Auckland
- c. Accommodation in China
- d. Activities scheduled as part of the Study Tour
- e. 2-3 orientations workshops
- f. Travel insurance
- \*Anything outside of this package shall be borne by the Selected Applicants, including meals and incidentals in China.
- \*The cost of Visa Application and travel to and from the Embassy/Consular Offices will be borne by the Selected Applicants
- 6) Selected Applicants must attend all activities on this study tour and notify North Asia CAPE in advance if they are unable to attend.
- 7) Selected Applicants must attend all locations scheduled that are part of the study tour, to participate fully at each location (requirements will be provided), and to co-operate with any promotional publicity related to the digital study tour.
- 8) Selected Applicants will be required to organise and pay for their own Visa to China.
- 9) Selected Applicants will be required to provide North Asia CAPE with either a final report, presentation, or video on their learnings and reflections from the study tour (guidelines will be provided).
- 10) North Asia CAPE has the power to amend or vary these Terms and Conditions and will notify Selected Applicants if it does so.
